1. Installation of Aadhaar Bio-Metric and C.C. Cameras immediately.
2. Linking of the College website to APSICHE and University Website.

The Principal is directed to follow the following norms.

1. The Principal should renew their affiliation each academic year.
2. The staff appointed should be qualified as per rules and regulations issued from time to time by the concerned University/Govt./APSICHE.
3. The Principal shall follow the rules issued by the Govt. from time to time with regard to the reservations in respect of admissions of students and appointment of staff.
4. Infrastructure like building accommodation, land playgrounds, Lab-equipment, Library, furniture etc., should be improved as per needs for the effective functioning of the college.
5. The College shall not be shifted to any another place without prior permission.
6. Sharing of the accommodation with the existing/other institutions is not admissible.
