1. Faculty details are to be upload in the Jnanabhumi Web Portal immediately.
2. Installation of Aadhaar Bio-Metric and C.C. Cameras immediately.
3. Linking of the College website to APSCH and University Website.

The Principal is directed to follow the following norms.

1. The Principal should renew their affiliation each academic year.
